



## P3 Member Pennsylvania Assets<sup>1</sup>

The PJM Power Providers Group (P3) is a non-profit organization that supports the development of properly designed and well-functioning markets in the PJM region.

Combined, P3 members own over 108,000 megawatts of generation assets and produce enough power to supply over 63 million homes in the PJM region, covering 13 states and the District of Columbia. In Pennsylvania alone, P3 members own nearly 35,000 megawatts (34,886.6 MW) of generation assets.

Collectively, P3 members have invested tens of billions of dollars into facilities in the PJM marketplace without any regulatory guarantee of a return on that investment. Combined, P3 members own and operate virtually all forms of electricity generation, provide demand response services in certain markets and serve end-use consumers through retail affiliates.
