



New or Restarted Generation Facilities in PJM

(Announced Since July 2024)

Following the July 2024 capacity auctions—which cleared near the Cost of New Entry (CONE) for the first time in two decades—the generation market has seen a surge in momentum. While misconceptions regarding market stagnation persist, the data tells a different story: substantial capital investment is rapidly mobilizing. This document details over 12,000 MW of new generation expected to enter the PJM regional grid, evidencing a definitive and robust market response.
